

## **Peace Social and Earth Concerns Committee (PSEC) Job Description:**

### **Mission and Purpose:**

The function of The Peace Social and Earth Concerns Committee (PSEC) is to help the Meeting to understand and implement Friends' testimonies and principles as they relate to the peace, social justice and environmental concerns identified as focus areas by MMM to be reviewed every 2-3 years. PSEC serves as a resource and linkage between Madison Monthly Meeting (MMM), other Friends meetings, and the larger community. PSEC assists the Meeting community in identifying opportunities for service and advocacy and facilitates consideration of PSEC concerns within the Meeting. PSEC cooperates with community organizations active in working against social, environmental and political injustice.

### **Structure:**

PSEC will consist of core committee members plus members who are representing specific Peace, Social and Earth Concerns Current concerns: Anti-racism work, Climate Change work, and resisting F-35's Fighter Jets.

- **Conveners** do the committee related work (convene meetings and handle organizational aspects of the committee like creating the agendas, scheduling forums, plan events etc.) as well as general help with PSEC work.
- **Members of the subcommittees** who are led to work on the focus issues identified by the Meeting will help plan and implement PSEC work connected to the specific concern including forum presentations.
- **Individuals with related concerns outside of focus issues** who are led to coordinate with PSEC in order to facilitate meeting-wide awareness and work on the identified concerns (like the F-35s Fighter Jets). This could include occasional forum presentations and articles in the newsletter.

### **Guiding principles:**

Friends believe that the congruence of inward leadings and outward action is an important part of daily faith practice, and living out our testimony is vital to a vibrant, deepening faith.

Arising from the Quaker belief of that of God/the seed of the Spirit in everyone and the equality testimony, Quakers are committed to work for peace and justice through nonviolent social change, alleviate the suffering caused by war and other social ills, promote justice in society, and encourage cooperation and harmony among all peoples. Being a 'Living Witness' to Peace is not a matter of dusting off the peace testimony in times of war. It is a matter of living a life that promotes justice and does 'take away the occasion for war' in connection to what our use of money supports via investments and purchasing choices, the work we choose, the relationships we foster and develop, our political involvement, how we raise our children... etc. We strive against evil not with weapons of violence, but by seeking that of the spirit in those through whom evil works, by building relationships strong enough to resolve conflict without violence, and by promoting a just and equitable world. - Adapted from PYM (Philadelphia Yearly Meeting Pamphlet, Quaker Peace Testimony by Mary Lou Leavitt, 2013 and from the Quakers In Britain website:

### **Duties and Responsibilities:**

- Educate and increase consciousness in ourselves and the Meeting on the peace, social and earth issues of concern to Friends and organize Quaker dialogues or worship sharing discussions, etc., on the issues and on the spiritual and historical roots of Friends' concern for peace, social and earth witness concerns.
- Consider how to forward the goal of Meeting to evolve into an anti-racist organization.
- Hear concerns of individuals within the Meeting related to PSEC concerns such as matters related to the Peace Testimony, concern for harmony with nature, and social justice issues.
- Monitor social justice and peace issues of current concern and share relevant information with the Meeting community to facilitate informed decision-making, action and advocacy opportunities on topics related to PSEC concerns.
- Help the Meeting select local peace, social and earth witness concerns focus topics as they arise and to support a Meeting group to create a Meeting-wide event or activity or action for each of the chosen topics.
- Identify issues of substantial concern meriting public action by the Meeting and present such for full consideration by the Meeting for Business. Any public action taken in the name of MMM and any individuals representing themselves as representing MMM requires approval of the Meeting for Business except that PSEC may approve MMM co-sponsorship of any event being put on by an organization currently approved for scheduled donations by MMM or associated with one of our identified focus areas.
- Keep informed of and promote communication on the work of subcommittees and interest groups organized around a specific peace, social and earth justice issues and report to Meeting regarding the activities.
- Support and partner with groups and/or individuals within Meeting who take on peace, social and earth concerns action

### **Specific duties for committee's members:**

- Educate self about peace, social and earth witness concerns and Friends' testimonies on these concerns.
- Assist and participate in arranging educational activities, advocacy efforts, and community partnering.
- Listen for promptings of the Spirit for how we are called to witness on matters of peace, social, and environmental concerns.
- Attend the PSEC Meetings and participate as able in Meeting for Business in order to stay current with Meeting Concerns.

### **Specific considerations for members in connection with their specific concerns**

- Connect with those in Meeting working on their concern
- Help to provide education to Meeting and to the wider community.
- Explore political advocacy (seek out related bills and organize plan of advocacy) and activism possibilities.
- Seek out other organizations doing same work and help build relationships with these organizations
- Inform Meeting of educational, volunteer, and advocacy opportunities.
- Keep PSEC informed regarding activities

### **Convener responsibilities other than above:**

- Prepare and send out the agenda and meeting reminders and clerk the meetings of the PSEC Committee
- Communicate with our Caretakers about reserving Meeting Space if needed.
- Arrange for someone to take notes at each committee meeting and to record decisions and keep archives of the committee work as needed.
- Coordinate and evaluate the PSEC committee work.
- With the committee's help, organize and lead projects related to PSEC objectives.
- Communicate with PSEC committee, as needed, between meetings.
- Provide PSEC reports to Meeting for Business as needed. Include when possible reference to consideration of this query: "How is Spirit leading us to consider the impact any decision made at this Meeting for Worship with Attention to Business may have on our goal for Madison Monthly Meeting to be an actively anti-racist faith community (and to additionally be mindful of also considering other types of oppression)?"
- Manage the budget set aside for PSEC in accordance with the guidelines for what PSEC can approve without taking it to Meeting for Business.
